Employed as a permanent member of the Cooperative Education faculty receiving the first promotion in 1996 to an Associate level and then became the first person in the department to be promoted to a Senior Coordinator position in 2004. Responsible for the management of the Pharmacy Cooperative (Co-op) Education Program with over 700 students, 150 employers and over 40 school faculty. The Co-op Program in Pharmacy assists students with early experiential skills and prepares them for employment in the pharmacy field. Co-op faculty prepares the student for the co-op process, promotes the success of the student on co-op, and facilitates reflection with the student upon their return to school. Measurable outcomes and assessment tools were developed by my colleague and me to document student achievement after each experience. The Pharmacy Cooperative Education Program meets the American Council of Pharmaceutical Education (ACPE)

introductory pharmacy practice experiential (IPPE) requirements, receiving the only exemption in the ACPE standards for the use of paid "renumerated" experience.

**Teaching:** To prepare the students to enter the professional work place, I developed and co-taught a co-op orientation series discussing topics including resume writing, interviewing skills, job offer evaluation, workplace behavior, sexual harassment issues, confidentiality of medical and proprietary information, and expectations of performance by pharmacists. This was formalized into a one credit course titled Pharmacy Co-op Seminar I in the fall of 1997 and was taught twice a year in the fall and winter quarters through the 2000-2001 academic year. The current course is Introduction to Pharmacy Practice which combines the Co-op preparation and search process with pharmacy practice skills. It is cotaught with Dr. Deb Reid and Dr. Deb Copeland from the pharmacy faculty, and taught every spring for sophomores and fall for direct entry students. In addition to the co-op topics, I also teach classes on sterile products, calculations, legislation and current practice trends.

**Service:** I participate in many University and School committees including School and College Curriculum, Assessment, Co-op Promotion, Co-op Mentoring, Global Co-op Employer Engagement, and previously Academic Standing. In addition, I assist with Open Houses, Welcome Days, Alumni Connections, White Coat Ceremony, Awards and graduation. I also write recommendations nominating students for School, University and external awards (US Public Health, MPhA Foundation, BDA Scholarships) with great success.
