## RESEARCH AND SCHOLARSHIP

My translational research program addresses three main areas in the field of aging and gerontology, including: (1) assessing the efficacy of nutrition and exercise interventions on chronic disease risk factors and health outcomes; (2) translating evidence-based lifestyle interventions into 'real world' settings for older adults; and (3) developing sustainable strategies to promote health and reduce the burden of impairment, disease and disability in older adults.
