2022-2023 Adapting a digital tool to improve contraceptive use and identify the needs and priorities of adolescents and young women in humanitarian setting

Calderone Junior Faculty Research Award, **Co-Investigator** (Sara E. Casey, PI; \$25,000) This project will adapt and test the feasibility, acceptability and pilot efficacy of an interactive contraceptive decision-making tool among displaced adolescent young women in Colombia. The tool assesses factors that drive decisions about contraceptive use or non-use that are rarely explored by adolescents in a clinical setting, or that adolescents are frequently unwilling to discuss with a provider. We will assess the acceptability and feasibility of the adapted tool among Venezuelan refugee and Colombian host community adolescents and young women, including structured cognitive interviews. Post-visit acceptability interviews will assess clients' perceptions of how it affected their interactions with providers. We will also adapt and revise the decision-making tool and conduct quality assurance testing of the adapted algorithm, including clinical validation of the recommendations generated by the decision-making tool for an adolescent population, using actual and clinical vignette patients.

2021-2023 A Prospective Observational Study of the Implementation of Telehealth-Supported LARC Provision in School-Based Health Centers

Merck Investigator Studies Program, **Principal Investigator**, **MPI with Melanie Gold** (\$478,192) This project will use quantitative survey data, electronic health record data, and qualitative surveys to 1) describe in detail the implementation of a hybrid model of telehealth-supported long-acting reversible contraception (LARC) service provision in a network of 6 school-based health centers (SBHCs) in New York City; 2) Quantify uptake of LARC (contraceptive implant, IUD) within the SBHC network following implementation of telehealth-supported LARC provision; and 3) assess, using person-time data, LARC continuation over a 6-18 month follow-up period among LARC initiators within the SBHC network. The findings from this study have the potential to inform and improve LARC service delivery for adolescents far beyond New York City and the SBHC setting.

2020-2023 Development and Pilot Testing of Sleeping Healthy/Living Healthy a Comprehensive Sleep Intervention for Adolescents in Urban SBHCs

NIH/NIMHD R21MD013991, **Principal Investigator**, **MPI with Jean-Marie Bruzzese** (\$459,952) Adolescents in general – and disproportionately urban, Black and Hispanic adolescents – get insufficient sleep, contributing to impaired functioning, poor academic performance, and increased chronic disease risk, but interventions are lacking to address their specific needs. We propose to

develop and to test the feasibility of a novel intervention that combines sleep hygiene with mind-body integrative health (MBIH) approaches (e.g. acupressure, aromatherapy, mindfulness, yoga) to improve sleep quality among predominantly Black and Hispanic adolescents with poor sleep quality served in urban school-based health centers (SBHCs).

2017-2023 Translating an Evidence-based Urban Asthma Program for Rural Adolescents: Testing Its Effectiveness & Cost-effectiveness and Understanding Implementation Factors

NIH/NHLBI, Co-Investigator (Jean-Marie Bruzzese, PI; \$2,897,995)

This study will test the effectiveness and cost-effectiveness of high school-based intervention with demonstrated efficacy in urban adolescents when delivered by Community Health Workers (CHWs) to rural adolescents with uncontrolled asthma, and will examine factors associated with delivery of the intervention.

The adapted intervention, guided by the findings from a formative research phase, will be tested in a two-arm randomized controlled trial using intent-to-treat analyses. Evaluation will also

include a rigorous process evaluation to assess fidelity and engagement with the intervention components.

The intervention development center will provide technical assistance to the Office on Women's Health in the development of a trauma-informed healthy weight initiative for women who have experienced adverse childhood experiences. Activities will include systematic reviews of methodologies to guide intervention development, convening an intervention design panel of

national experts, and development of a research protocol including outcome measures, SMART objectives, eligibility criteria, and sample size calculations.

2015-2016 Supporting Adolescents' Continuation of Long-Acting Reversible Contraception: Concept Development and Feasibility Testing of a Theory-Based Interactive App

Mailman School of Public Health Internal Funding (Calderone Junior Faculty Research Prize), **Principal Investigator** (\$25,000)

This project will support the necessary formative research to support the development of an app to provide information and education support for young women who use long-acting reversible contraceptive methods (IUDs and contraceptive implants). The research seeks to answer three key questions: 1) What are the information and support needs of adolescents who have recently initiated LARC methods? 2) Is a theory-guided app a feasible and acceptable approach to provide information and support to adolescents who use LARC methods? 3) Would specific interactive elements such as gamification, tracking and reminders, clinic locators, ways to communicate with providers, or information sharing, be an effective and appropriate way to increase engagement with the app? Findings from this research will guide the future development and testing of a theory-based interactive app for adolescents to promote satisfaction with and continued use of LARC methods.

Formative Research: Reaching African-American Youth to address Urban Challenges including Sexual & Reproductive Health through a New Media (video) Serial Drama with Transmedia Elements Population Media Center, Co-Principal Investigator with John S. Santelli (\$120,204)

This project will conduct formative research to inform the development and production of a transmedia television serial drama targeting adolescents (age 12-18) of color, primarily African American youth living in urban centers in the United States. The focus of this new transmedia television serial will be to model healthy decision-making and life skills, to provide information and support about comprehensive reproductive health options, and to promote social change at the individual and community levels. The serial drama will be developed using the Sabido methodology, which is grounded in research conducted prior to, during, and after the program. This allows for a nuanced approach when addressing complex and sensitive issues, as the characters are designed based on research about the audience's everyday life.
