RISE Expo




Salus Populi

The IHESJR continues to lead the Broad Trauma Initiative (BTI) Community Engagement Core (PI: Lincoln). This work allows us to provide support and guidance to BTI affiliated investigators seeking to explore or increase community-engaged research practices. In addition, the group is conducting the PaTH Study to improve our understanding of how community members who have experienced a wide range of traumas, think about and make meaning of how trauma impacts their health and well-being. This qualitative study is driven by our active community-advisory board (CAB) with members from our partner organizations.

The Salus Populi judicial education program (JEP), with funding from the Robert Wood Johnson Foundation and W.K. Kellogg Foundation, provides judges with the tools they need to recognize how the social determinants of health (SDOH) impact the issues that come before courts, the court's impact on the SDOH, and tools to engage with research relating to the SDOH. The program is a collaboration of the Center for Health Policy and Law and the Institute for Health Equity and Social Justice Research including the NU-PEL. Salus Populi is led by Profs. Wendy Parmet and Alisa Lincoln, and Prof. Katherine Hazen leads the evaluation team with many IHESJR students. The Salus Populi initiative IHESJR Faculty Scholars including Profs. -Danielle Crookes, Beth Molnar and Associate Director Idia Thurston have all contributed as Guest Lecturers. To date the Salus Populi team has trained more than 1500 judges nation-wide.



Broad Trauma Initiative



The ACE Resource Network (ARN) works to build awareness of Adverse Childhood Experiences (ACEs) and to prevent and mitigate the impacts of childhood adversity and toxic stress. NU-PEL partnered with ARN to conduct a comprehensive evaluation of all components of this initiative, including the evaluation of ARN-funded initiatives at five Sacramento-based CBOs and the implementation and analysis of a community survey conducted at two timepoints with a representative sample of adults living in Sacramento County.



STAR (Stimulating Training and Access to HIV Research Experiences)

This project is part of a British Academy-funded initiative, to bring together partners from the UK, USA, South Africa, Ethiopia, and Uganda, with the first convening held in Durban, South Africa in summer 2023. As one of several research teams within the initiative, the CHANGE Lab has partnered with collaborators in Uganda and Ethiopia to focus on decolonizing approaches to understanding African refugee experiences. The project challenges dominant illnessbased narratives by centering wellness, resilience, and growth.



Research Evaluation Course (PPUA 6509)





Healthy Relationship Project <a>L

Full Title: Evaluation of the School-Based Healthy Relationships Project for Primary Prevention of Child Sexual Abuse among Children Pre-K through 5th Grade

About: HRP is a child sexual abuse prevention initiative being implemented in D.C. schools to educate students about healthy relationships. NEU researchers evaluate the program via data collection on cases of child abuse, surveys about what caregivers are learning from the program, and interviews with school teachers, administrators, and caregivers.
